# Role Specific

- Instruct lessons for students in water safety, water familiarisation, learn to swim and squad.
- Lesson planning and teaching with an emphasis on safety, and variety for participants.
- Evaluate and adjust lesson plans accordingly to cater for the needs of the students.
- Organise and monitor the condition of teaching equipment each lesson.
- Regularly assess student's progress
- Assist in providing a customer orientated environment.
- Promote teamwork and communication through collaborative work practices.
- Attend and complete training as required (includes external, internal, and on-the-job training).
- Use clear communication skills to liaise with clients, parents, teachers, and the community.
- Implementation of industry standard systems and procedures.
- Ensure safe work practices are adopted in the work area and contribute to the development and maintenance of work method statements.
- Report injuries, accidents, incidents and near misses within the facility, and act on the corrective actions taken to prevent reoccurrence.
- Use and properly maintain appropriate safety clothing and personal protective equipment.
- Contribute to improved customer service and organisational effectiveness, by acting ethically, honesty and with fairness.
