POSITION OVERVIEW

The focus of this position is to manage the risks associated with trees in an urban environment and maintain the ongoing viability of the urban forest in accordance with Australian Standards, industry best practice and City of Parramatta strategies and policies. This position also has a strong focus on customer service and conflict resolution while ensuring quality outcomes and WHS compliance.

KEY RESPONSIBILITIES

Role Specific

- Inspect street and park trees and assess them regarding tree species, health, structural integrity and
 risk to the community. Document this information and make recommendations for remedial works,
 including removal, replanting;
- Undertake and administer inspections, recommendations and reporting for tree bonds, requests related to development or construction activities and tree offset fees and plantings.
- Manage and coordinate the public tree planting program.
- Carry out investigations into issues such as insurance claims and similar matters relating to trees and providing relevant reports;
- Assess the impacts of proposed developments on existing trees;
- Review compliance with tree protection conditions and bonds
- Maintain and update relevant data bases such as the management and ongoing updating of tree management software.
- Prepare evidence for submission to Council and legal authorities where litigation is or may be involved;
- Act as an expert witness in the Land and Environment Court and Local Court as required;
- Prepare reports for insurance claims regarding trees;
- Undertake and administer construction inspections of internal and external capital works that will be handed to parks and open space as the asset owner
- Provide technical and procedural advice within parks and open space including works associated with development activities and ensuring council specifications, DA and VPA conditions are met.
- Provide SME input to generate annual and long term renewal and maintenance programs consistent with asset management policy, strategies and plans for parks and open assets
